



Minutes of the Brookenby Parish Council held at 7.00 pm at the Community Centre, Kent Road, Brookenby on 5 July 2022

1 Public Session - 15 minutes - Ref: 2508

A resident asked whether the Council had met with a property developer. The Clerk confirmed that some councillors had met with a property developer and councillors are entitled to meet with anybody at anytime, in the same way as a resident can meet with a councillor to express views or also meet with the developer. The resident questioned the legality of such a meeting and the Clerk reiterated that councillors can meet with whoever they wish at anytime but that any decisions made by Council had to be within a public meeting. The resident further alleged that no consultation with residents had taken place. The Clerk stated that the developer's revised plan was presented at the May meeting and it was the first time either the Council or residents had seen it. The Clerk confirmed that everything had been done that should have been done at that meeting and in order to give residents the chance to view the plans and ask questions of the developer (who was in attendance) then the standing orders at the meeting in May had been suspended for 15 minutes to allow the developer to talk to residents before Council made a decision. This did not to have been done but was allowed to enable engagement. The resident then stated that he had met the developer and then he further alleged that councillor(s) had made a personal gain from their meeting with the developer. The Clerk asked which councillors he was referring to but he declined to name anybody but that he had text messages and emails as proof. The Clerk warned him about making such a serious allegation in a public meeting. The clerk then reiterated that the Councillor in the May meeting had voted to say that the plan presented met with their approval but that the developer would need to submit a formal planning application in due course and that would then come back to the PC for review and decision

A resident asked a question in respect of trees within the village. The Clerk confirmed a tree surveyor had undertaken a survey on Parish Council owned trees recently with no areas of immediate concern. Trees not on land owned by the Council was the responsibility of that land owner and not that of the Parish Council.

The Clerk had circulated a report which was verbally summarised at the meeting.

It was resolved to accept all recommendations in the report and to provide a grant of £3000 to the Allotment Association.

The Clerk circulated a report detailing the results of a recent survey as to whether to re-home the peacocks or for them to remain in the village.

54% voted to re-home whilst 47% voted for them to remain.

The Clerk confirmed that Wolds Wildlife Park had agreed to re-home the birds.

Based on the results and proposals for re-homing it was resolved to re-home the peacocks.
