The Parish Grass cutting was raised and it was again explained that the Parish Council could only use public money to cut grass on the land they owned or which they were paid to cut by the County Council. Two other issues were raised which would be considered for the July agenda

 Correspondence had been received requesting that the Council support a campaign to improve the safety of Lithium Batteries and their disposal. The proposed measures were supported by the Council. Proposed Cllr Sumnall, Seconded Cllr Turnbull

- Avoidable Flooding on York Road. Residents had asked that the Council lend their support to their efforts to get action from higher tier government. The Clerk was directed to write on the Council's behalf. Proposed Cllr Coulam, Seconded Cllr Sumnall
- Pre-election Period of Sensitivity. The Clerk shared the LALC guidance.
- Benches on Swinhope Road. In response to a request to either repair or replace the benches, the Council could not commit Parish funds on items that were neither on Parish land or owned by the Parish. Funding for replacement may be available via Cllr T Smith (WLDC & LCC)
- The Cinema Group had requested use of the community centre for planning progress with the project. Approved unanimously
- LCC had notified an increase in the Urban Grass Verge contribution to £2200
- Correspondence continued to be received about both land ownership and management charges payable to the, now defunct, management company.
- Following correspondence with the approved contractor, the Parish had been provided with a portrait of HM The King. The portrait was shown to the meeting and it was agreed it should be displayed in the Foyer.

Cllr Preece asked about correspondence for inclusion in "The Flyer" and it was agreed that any contributions would be forwarded to Cllr Preece who would collate them and submit them to the editor.
