Ref 2953 To receive any reports from external organisations to include Ward Councillor Allotments Association and Wolds Community Activity Group (WCAG)

Cllr T. Smith (LCC and WLDC) reported that the 30 MPH speed limits signs had been installed on Swinhope Road and the revised limit was, therefore, in effect.

He further reported that there were no further legal remedies that the (District) Council could take over the issues with the York Road construction. This was because of a lack of conditions imposed by the Planning Inspector. Subsequent issues arising should be subject to complaint as they arise.

There was nothing raised by the Allotments Association other than criminal damage which would be covered in the Clerk's report.

WCAG reported that a Table Tennis session was due to be delivered on 13 August and they would liaise for future dates. The "Schools Out" football programme was delayed due to Magna Vitae availability.

Cllr Preece updated the meeting that we had progressed through stage 1 of the grant process but further information had been requested for stage 2 consideration

Clerk's Report

Ref 2959 Community Centre

The Clerk reported that the Community Centre continued to be the Council's largest expense and his most time consuming single activity. Damage to the water harvesting system had diminished but not entirely ceased. He had made several approaches but had not yet engaged anyone to undertake the physical security work required.

Ref 2960 Correspondence

The Clerk reported that there had been further correspondence with the Scout Association about their enquiry as to running a Scout Group in the Community Centre. Councillors had enquired as to the number of members of the group but, as the intention was now to form a new group, numbers were unknown.

Last year, Kent University and Northern Lincolnshire Archaeology and History Society held an exhibition in the Community Centre of historic roman finds recovered locally and gave a lecture on the roman era history of the area. They had booked the Lancaster Room to repeat this on 7th September this year.

They had requested limited use of the community Centre in the preceding week for "pot washing" (the cleaning of finds recovered) and for welfare use of the participants.

It was resolved to allow free use of the Centre for this purpose. Proposed: Cllr Coulam. Seconded: Cllr Sumnall. All in Favour.
