Minutes of the Brookenby Parish Council Meeting held at 7.00 pm

at the Community Centre, Kent Road, Brookenby on 1st July 2025

Public Session

A member of the public expressed appreciation of the new play park which was now partially constructed. There was a discussion about the usage of the playpark when completed and Cllr Coulam, seconded by Cllr Fraser proposed that a sum of £250 be allocated for the provision of litter bins. All the Councillors were in favour.

Highways and street lighting matters were again raised. Person told this was not a Parish Council matter and Cllr Smith again advised that they be reported via "Fix my street".

The Chair of Brookenby Community Group reported that: The Group was looking to replace 2 Benches on Swinhope Road The village Summer Fair would take place on 23 August

The Chair of the Allotments Association offered, on behalf of the Assocition to install the Commemorative bench previously bought by the Council at the site of the new play park. This offer was accepted with thanks.

There was no report from the Police but the Clerk reported that there would be a "Teams" meeting between local Parish Councils and the Police on 25/09/25

Cllr Preece questioned whether the various provisions of Section 3 of the "new" Standing orders would inhibit public engagement. Councillors were of the opinion that the section provided a toolbox of measures for the Chair that were permissive to maintain order but would not be used in a manner to stifle open discussion.
